2 The Court, having considered the Application for Partial Disbursement
3 of Settlement Funds, in consideration of its obligations under the Federal Rules,
4 and for good cause appearing, IT IS HEREBY ORDERED:
5

- 6 1) The proposed partial disbursement of settlement funds in the amount of
7 \$8,534,601.17 to approved claimants, as specified in Exhibit "B" is
8 approved;
9 2) Those claimants, whose claims have been approved by the Settlement
10 Fund Board, shall have four months from the date of the Settlement
11 check, in which to cash or deposit their settlement check;
12 3) The denial by the Settlement Fund Board of the 12,550 claims, as
13 specified in Exhibit "B" is approved;
14 4) The decisions made by the Settlement Fund Board, in approving or
15 denying the submitted claims, are final, with no right of appeal; and
16 5) With respect to the 261 claims identified in Exhibit F, the Settlement
17 Fund Board and Class Counsel shall have up to and including December
18 31, 2009 to either approve or reject these 261 claims.
